You do **not** have the right to complete a course if you hold a commercial driver's license, if you held a commercial driver's license when the offense was committed, or if you are charged with passing a school bus, failing to stop and give information or render aid following an accident, or a traffic offense committed in a construction and maintenance work zone while workers were present, or if you were speeding 25 miles per hour or more over the posted speed limit. You must have a valid **Texas** driver's license or permit, or you must be a member of the United States military forces serving on active duty. You must have proof of liability insurance (financial responsibility). You may not take the course if you are taking the course at the time of this request, or if you have completed such a course within the 12 months preceding the date of the offense.

In order to take an approved Driving Safety Course or Motorcycle Operator Training and Safety Program, you must elect and request to do so. You may complete this form and return it to the Court with a copy of your proof of liability insurance or other financial responsibility and payment of costs. This request must be received by the Court prior to the appearance date on your ticket. If you intend to use the mail, you must use certified mail, return receipt requested, postmarked on or before the answer date on your ticket.

Costs: If your offense date is before September 1, 2005, the DSC fee is \$91.00. If your offense date is between September 1 and December 31, 2005, the DSC fee is \$95.00. If your offense is on or after January 1, 2006, the DSC fee is \$100.00. If your offense is on or after March 1, 2007, the DSC fee is \$105.00.

Juveniles: A defendant who is younger than 17 years of age must appear in court with a parent, guardian, or managing conservator, to enter a plea and request to take a Driving Safety Course or Motorcycle Operator Training and Safety Program.
